1. ice report questions
 - a. Condenser: John Geason asked about the condenser. Larry Laux reported that the board approved purchasing a new, larger condenser. Questions posed: i) Expansion of season? - Bob Dixon ii) Energy grant possible? – Steve Hogan

 - b. Need ice volunteers for events for next season – Larry Laux stated that the leagues were ok with getting help but we need more volunteers for bonspiels. The old board had provided for \$50/day for ice prep. Any

payments over \$600 requires tax filings (IRS 1099). Larry suggested that club members to leave \$5 “tip” to go to the ice crew. John Geason stated that the board approved monies for 2 brunches as a thank you to the ice crew. Jim Ellis reported that the “winners” of a club event donated their prize and bought a gas gift card for Ice guy.

2. Equity membership

Steve Everett asked if members could buy into equity to become full members. This would require a change to the by-laws. It will be discussed by the board.

- b. Board of Directors nominees – Bob Dixon asked if we should nominate more candidates than for the available open positions. The by-laws allow for someone to be added by contacting the nominating committee.
